BUS PASS APPLICATION PROCESS

The timeline and process for submitting bus pass applications is outlined on the school district website www.sd69.bc.ca under School Bus Information.

Similar to the process that was started this past year, the district we will be issuing eligible rider bus passes first, but with a **cut off date** to have them in by, followed by courtesy rider bus passes as space allows.
