#### 1. CALL TO ORDER

Chair Flynn called the zoom meeting to order at 6:00 p.m. and welcomed Trustee Barry Kurland back to the Zoom Board Table.

#### 2. ACKNOWLEDGEMENT OF TRADITIONAL TERRITORY

Chair Flynn acknowledged that the Board was meeting via zoom on the unceded territory of the Coast Salish people and thanked the Snaw-Naw-As (Nanoose) and Qualicum First Nations for allowing the board to live, work and play on their shared territory.

She then acknowledged the lives lost that have been, and continue to be, identified on land of residential schools which has brought to bear the Truth & Reconciliation that still must occur. June is National Indigenous Month and June 21st was the 25th anniversary of National Indigenous Peoples Day and she quoted the following from Premier Horgan: "I am humbled to walk the path of reconciliation in partnership with Indigenous people, toward a better future for every community", noting that it would be point from which to 'go-forward'.

Chair Flynn than acknowledged Debbie Comer, outgoing MATA President, for her service to the MATA and wish her well in Bowser. She then welcomed Matt Woods, incoming MATA president.

She also acknowledged the work of Dr. Vivian Collyer over the past 2 years as Director of Instruction, most notably her work with climate action, French Immersion, assessment and Math. Dr. Collyer was wished well in her move to SD71.

Chair Flynn noted that it was the last meeting at which Superintendent Elder would be present as his contract with the district was ending and he was retiring (for the second time). On behalf of the whole district, she expressed her deep appreciation for Dr. Keven Elder's willingness to support SD69 during absence of past Superintendent and for his continued leadership over the past 3 years. She wished him all the best in his future endeavours.

#### 7. MOUNT ARROWSMITH TEACHERS' ASSOCIATION (MATA)

Deb Comer, President, commented on the following:

- Welcomed back to Trustee Kurland
- With the vaccines being provided, it makes for a promising start to the September school year and MATA will continue to work with the District to make sure the necessary protocols are in place for the start of school year
- She thanked the teachers who rose admirably to the challenge with professionalism, integrity and care for the health and safety of students during the pandemic.
- She hoped that government funding would continue to support maintaining the covid protocols that were put in place and also to maintain daytime custodians.
- Ms. Comer then acknowledged the following: CUPE for supporting teachers throughout the school year with ever changing and evolving health orders; bus drivers for ensuring that students arrived at school and home in a safe clean environment; Operations and Maintenance staff for maintaining safe and healthy schools and updating one of the teacherages at False Bay School on Lasqueti Island.

Secretary Treasurer Amos reported that last month the district had a response letter from the Ministry advising that they approved \$1.5m for the Ballenas roof upgrade. Following that approval a priority need for the Ballenas HVAC system was identified and after receiving bids for the roofing below \$1.5m, a request was submitted to the Ministry to divert \$500,000 of the funds to the HVAC roof. That has been approved with an amended response letter from the Ministry, hence the need for an amended bylaw to reflect the reallocation of funds.

#### 12. INFORMATION ITEMS

#### a. Superintendent's Report

#### i. Framework for Enhancing Student Learning (FESL)

Superintendent Elder reviewed the information contained in his briefing note regarding the requirement for school districts to prepare and submit to the Ministry by September 30 of each year a report in keeping with the ESL Reporting Ministerial Order. The extracted portion provided in the agenda package is the way in which the district has extracted the data in key areas and in sub level data where available. The final draft will be presented in September for the board's receipt and sent to the Ministry for its consideration.

#### ii. Community School Report

Superintendent Elder referred to his briefing note provided in the agenda package outlining the history and context of community schools, following which he presented some options for the Board to consider. He noted that, while the Board has been presented with an opportunity through an offer of support in at least a planning capacity from the United Way Lower Mainland, it was worth keeping in mind that the nine elements of community schools are already present to a large degree within the district's current partnerships. He suggested that the Board may wish to consider Step 1: to establish a working group to review the extent to which community school practices are already in place in SD69.

Trustees discussed the information provided and, while supporting the concept in theory, that the timeline suggested be moved forward and that it be considered within the context of the upcoming land and facilities review planned for the fall.

Chair Flynn served notice of motion to the recommendation within the Superintendent's briefing note that In September she would move or cause to move the following:

THAT the Board of Education of School District 69 (Qualicum) direct senior staff to undertake Step 1: Working Group as described in the Superintendent's report to the Board dated June 22, 2021 at the August Board Meeting.

#### iii. September K-12 Restart Plan 2021

Superintendent Elder referred to the K-12 Education Recovery Plan 2021 published by the Ministry of Education to provide direction to boards of education to deliver educational programs and supports in line with provincial pandemic recovery efforts in the 2021/22 school year. The plan is within the context of the Step 4 reopening of society in BC for schools to reopen in a relatively pre-covid normal. The ministry has picked up on the idea that some things have been learned during the pandemic period which may benefit districts going forward. There has been a healthy analysis in the district's schools in that regard to determine what may be of benefit in terms of instructional practices and what public health requirements will be as of September, which are hoped to be minimal. The government has also provided additional funding for cleaning resources and materials as well as for mental ill-health.

Associate Superintendent noted that there are 2 parts to the mental ill-health topic. The first is the continuation of what we have for the last 2 years and there will be 15 districts in a special pilot-type of program where they are focusing on mental health and SD69 has expressed an interest in being part of that pilot given the work it has been doing on brain science and trauma informed practice.

Dr. Elder then expressed his profound appreciation at having the opportunity to work and liaise with the staff, parents, stakeholders throughout the district and for the trust placed in him during his time as Superintendent of Schools over the past 3 years. He is now looking forward to continuing to be a part of the community and community of schools.

#### b. Educational Programs Update

Vivian Collyer, Director of Instruction, reported on the following:

- Timelines to receive the draft of the new K-12 reporting order for assessment was changed from spring 2021 to August 2021. That document will be shared and the assessment evaluation and student learning committees will have the opportunity to provide feedback in the fall.
- The Ministry is replacing the performance standards with Literacy and Numeracy proficiencies and SD69 is taking the lead with K-5 teachers piloting the new draft which includes lesson ideas and work samples to inform the draft proficiencies. Dr. Collyer and others are providing feedback which the Ministry is taking under advisement. She acknowledged Tandy Gunn and Mark McInnes for their leadership in working with the team of teachers who are working on the draft proficiencies. The Ministry will be drafting the 6-12 proficiencies and teachers will have the opportunity to trial them in January 2022.
- Dr. Collyer thanked everyone for their kind words and stated that it has been a pleasure and honour to work with the board and colleagues and school teams. In spite of the pandemic, there have been many other positive moments and she was certain she would be interacting with many from the district while in her new role at SD71.

Gillian Wilson, Associate Superintendent, reported on the following:

- Thank you to Deb Comer, outgoing MATA President she will be missed at the liaison meetings and welcomed at Bowser Elementary School.
- Based on feedback to the Ministry regarding the challenges in applying to VIHA for licensing for seamless day programs in schools due to differing requirements between a 'school' and 'childcare' facility, government policy has been changed with new requirements related to seamless day programs being provided in schools. The Errington site had its inspection on Monday, June 21<sup>st</sup> and the application has been forwarded to the senior licensee and it is anticipated that the district will receive its license within the next 10 days and can offer the program in September. There is already a list of interested families.
- A second application has been submitted for a seamless day attached to the Primary Learning Community Program and with the new licensing requirements, it is anticipated that it should not take as long to be licensed once the renovations are completed at the Craig Street Commons.
- Welcome to Kindergarten events have taken place at all elementary schools.
- Enrolment projections are well on target if not slightly above and 3 divisions have been released at 3 schools as well as staffing.
- Ms. Wilson gave credit to the principals and vice principals for their dedication and tenacity in keeping the buildings functioning well this year.
   They worked with CUPE support staff, advocated for the school and teachers and now it will be time for their well-deserved vacation.
- She then acknowledgement teachers and support staff for their work during what has been a very challenging year during which a lot was learned. Staff are looking forward to the restart of school in September and resuming some initiatives that had to be set aside due to the pandemic.

Trustee Flynn referred to her report provided in the agenda package, noting that the only outcome of discussions was the amendment to the capital bylaw as was passed earlier in the meeting.

#### 17. TRUSTEE ITEMS

#### a. 2021-2022 Trustee Meeting Schedule

As provided in the agenda package. It was noted that the Board would still be considering options as to how best to provide a hybrid model for in-person and online viewing of the public board meetings.

#### b. Climate Action Task Force

Trustee Austin drew attendees' attention to the report on the Green Teams by Dr. Collyer which was provided in the agenda package and thanked Dr. Collyer for taking the lead on that project. She has laid the groundwork and inspired teachers and students to continue that work.

Trustee Austin then gave notice of her intention to propose a motion for the the Board of Education of School District 69 (Qualicum) to join the West Coast Climate Action Network (WCCAN) at the August Board Meeting. This follows correspondence she has had with Guy Dauncey, one of the members of WCCAN, who had mentioned that the network is seeking an educational focus with participation by K-12 and post-secondary institutions.

Trustee Young suggested that as the Board begins to meet with the local MLA's and possibly with the MP in the fall, that the Green Teams Report is sent out to showcase what is being done in the school district to reduce the carbon footprint. It was also suggested that a copy of the report also be sent to Seth Klein, Team Lead and Director of Strategy with the Climate Emergency Unit. Trustee Young offered to also do a personal follow-up as she is acquainted with him.

#### c. Early Learning & Childcare Council in Oceanside (ELCCO)

Trustee Austin noted that Associate Superintendent Wilson had provided some of the information she was seeking during her report regarding the new ministry guidelines and the child care licensing regulation exemptions and wondered whether there might be something else of note arising from the proposed legislation.

Associate Superintendent Wilson noted that the legislation is already in place, the island child care licensing supervisor had just received the information and staff were being briefed. The district's application will be processed under the new regulations.

Trustee Austin then advised that one of the questions at the ELCCO meeting was how to introduce and encourage students to consider early childhood education (ECE) as a career choice.

Associate Superintendent Wilson advised that the district has two initiatives underway which are the same as for education assistants (EAs). There are plans to have a semester of specific ECE training at Ballenas which would provide students with the equivalency of an ECE at the end of Grade 12. The district has also been successful in having students do courses through the Head Start program at either Vancouver Island University or North Island College.

Trustee Austin stated that the sector often feels unappreciated and is traditionally underpaid; however, she has heard that the province is working towards providing a living wage to make it a more viable career choice. Associate Superintendent Wilson added that the move towards a higher wage is being supported by the

realization of how crucial the need is for early learning for ages 0-6; it may change but it may also take some time.

#### d. Oceanside Community Track Update

Trustee Young reported the following from the meeting held earlier in the day:

- the Board would be meeting with MLA Adam Walker in the fall.
- Dr. Elder reported that the district has a Physical Literacy Lead in each of its schools.
- Town of Qualicum Beach will be voting on contributing funds to the track renewal. She will be sending councilors a document outlining 10 reasons to support the track.
- The contribution from the City of Parksville is more or less confirmed
- The Regional District of Nanaimo, through the Oceanside Services Committee has recommended funding from its reserves and some work grants and was being discussed at a meeting held earlier in the day.
- There are a number of fundraisers that have been and are being held as well as grant applications being submitted.
- Businesses will be approached this summer to generate support the track

Superintendent Elder added that the number of fundraisers being held demonstrates a substantial community-wide excitement for the project, which also raises the project's profile in terms of obtaining donations and grants.

#### Education roundtable defines anti-racism action plan

VICTORIA – A community roundtable will bring together nearly 40 community organizations, rightsholders and education partners to address racism in education and help shape the provincial K-12 Anti-Racism in Education Action Plan.

"Through the community roundtable, we will listen and learn how to build more inclusive and supportive school communities and programs and develop concrete actions that will inspire staff and students to create systemic change," said Jennifer Whiteside, Minister of Education. "When we work together with rightsholders, education partners and community organizations through an open and ongoing dialogue, we can address intolerance and colonial bias and build welcoming and inclusive learning environments for students and staff."

Fighting racism is more urgent than ever, given escalating racism and intolerance in B.C. in the past year.

The July 15, 2021, virtual meeting with breakout sessions will allow participants from throughout the province to discuss topics, themes and actions to address racism, and support inclusivity and equality. It will build on the feedback provided in the first education roundtable on anti-racism, which was held in July 2020 and helped form the foundation for the draft action plan that will be presented and discussed for final input.

The five key elements of the draft anti-racism action plan are provincial leadership, system leadership, system support, workforce development and raising awareness. The action plan is expected to be launched this year.

"By teaching our children the colonial history of B.C. and giving them the tools to tackle racism, we are building welcoming and inclusive communities for everyone," said Rachna Singh, Parliamentary Secretary for Anti-Racism Initiatives, who will participate in the roundtable. "Indigenous peoples and Black-led community organizations have been leading anti-racism work within education for a long time, and I am eager to listen to them and support their voices."

The ministry is working with teachers and community partners to create an inventory of K-12 anti-racism and diverse cultural experiences, learning and teaching resources with a particular focus on the B.C. context. This is complementary to B.C.'s K-12 provincial curriculum, which directly supports students in their growth. The personal and social core competencies include the awareness, understanding and appreciation of connections among people and encourages the study of topics related to diversity and inclusion through the investigation of local contexts and student interests. Through the action plan, a minister's student advisory council will be formed, and youth engagement events will be planned throughout the province.

In the past year, the ministry has expanded its Expect Respect and a Safe Education (Erase) strategy to include Erase racism resources and information for students and parents. Training has also been included in the strategy for school districts to specifically address racism in schools.

"As we look toward the next school year, we know many students and staff in our schools will have experienced different forms of trauma because of the pandemic. We also need to make sure we tie this work to promoting and training people in trauma-informed practices so the school system has the tools to respond and support people who have been the targets of racism. We also need to work together to ensure there are updated teaching resources available to all educators to help teach and promote anti-racism, decolonization, and anti-oppression."

We continue to listen and to learn so we can work together on this critical task."

#### Joint statement on National Summit on Islamophobia

VICTORIA – Rachna Singh, Parliamentary Secretary for Anti-Racism Initiatives, and Jennifer Whiteside, Minister of Education, have released the following statement for the National Summit on Islamophobia, hosted by the Government of Canada on Thursday, July 22, 2021:

"Over the past year, we've seen a significant increase in hateful attacks against Muslims across Canada. In June, the cowardly attack in London, Ontario shocked the country, taking the lives of four members of the community and leaving a son without a family.

"In B.C., we've also seen a rise in anti-Muslim comments on social media, women attacked by white supremacists for wearing a hijab, and just last week, Islamophobic slogans were graffitied across a block in Surrey-Newton. This is unacceptable and cannot continue.

"Government has a moral and ethical obligation to dismantle racism. We are committed to tackling hatred and discrimination of all kinds in B.C., but we know we must back it up with real action.

"We have committed to introduce a new anti-racism act to make B.C. a safer, more welcoming and equitable province for everyone, regardless of their race, skin colour or faith. As well, we'll introduce anti-racism data legislation, to provide better and more equitable services to communities.

"And while government works on these priorities, we know communities that are experiencing racism and hate right now can't wait.

"That's why we launched a provincewide anti-racism awareness campaign and provided millions of dollars in grants to communities across B.C. for grassroots anti-racism projects and our Resilience BC Anti-Racism Network. This includes funding for Islam Unravelled to work with communities on ways to stop faith-based hate.

"We are working to create a new multilingual racist incident hotline to help British Columbians report racist incidents and receive support and referrals. We are also reviewing the Police Act and looking at options to deter hate groups from registering as societies in B.C. In addition, the BC Prosecution Service has a policy on hate crimes that provides guidance to prosecutors dealing with offences motivated by the offender's bias, prejudice or hate towards others.

"Education also has a significant role to play in stamping out discrimination in our communities. By teaching our children the colonial history of B.C. and highlighting local Muslim stories, we are giving them the tools to tackle Islamophobia and build a more inclusive province for everyone.

"The curriculum includes topics relevant to Islamophobia, such as diversity, inclusion and the prevention of discrimination. The Ministry of Education is currently creating a K-12 anti-racism action plan to give students and staff guidance on how to respond to incidents of racism.

"As well, the provincial Erase strategy (Expect Respect and a Safe Education) has been recently expanded to include Erase racism resources and information for students, staff and parents, which promotes inclusion and diversity.

"Racism and hate are hurting people in our communities, and it takes all of our collective voices to stand in solidarity against hate in any of its forms.

"We look forward to reviewing the recommendations by the National Council of Canadian Muslims in the upcoming days and working with the federal government and members of the Muslim community to build a country where everyone is treated with mutual respect, dignity and kindness."

#### Health, safety remain focus for new school year

VICTORIA – B.C. students will return to school next month and can look forward to full-time, inperson learning and resuming sports, music and other extracurricular activities, while mask requirements and other health and safety measures remain in place to keep schools safe.

"We know how excited students and families are about being back in school with extracurricular and sports programs and how important it is for children to be connected to their teachers and friends on a full-time basis," said Jennifer Whiteside, Minister of Education. "We also know we can do this safely, even as the pandemic continues to present challenges. B.C. was one of the few jurisdictions in Canada to keep schools open and safe last year thanks to the monumental efforts of everyone in the education system. The precautions we are announcing today allow students to continue learning in school with safeguards in place, so they have every opportunity to achieve their best."

Research by the BC Centre for Disease Control (BCCDC) last year noted a significant impact on students from remote learning, including interrupted learning, increased child stress, decreased connection, increased loneliness and mental and emotional health effects. Studies by the Vancouver Coastal Health Authority and Fraser Health Authority showed that after a resumption of in-class learning, schools were not significant sources of COVID-19 transmission.

In addition to the continuation of indoor mask requirements for all K-12 staff, visitors and students in grades 4 to 12, changes to the health and safety measures also include the ability for health authorities to introduce additional regional measures specific to individual schools or school districts in instances where community transmission rates are higher.

There will be greater opportunities for school sports and extracurricular activities, continued increased ventilation and improvements in schools, and daily cleaning and disinfecting protocols, along with a continued focus on hand hygiene. Students will continue to be required to complete daily health checks and stay home when feeling sick. Rapid response teams will continue to operate throughout B.C., working with health authorities and school districts to provide support and review school communicable disease plans to keep schools safe.

"We know last school year was challenging in many different ways for B.C. students, but they persevered and finished the school year strong," said Dr. Bonnie Henry, provincial health officer. "While we are encouraged to see rising vaccination rates in most parts of the province, we need every eligible British Columbian, including children and youth aged 12 to 19, to receive vaccinations as they begin the new school year."

School districts will continue to ensure all mechanical heating, ventilation and air conditioning (HVAC) systems are designed, operated and maintained to their standards and specifications so

they continue to work properly. All school HVAC systems will continue to be regularly inspected and, moving forward, provincial funding will continue to be made available to upgrade or replace HVAC systems through routine capital programs.

A total of \$87.5 million has been used to improve school ventilation in B.C. schools, including \$77.5 million through provincial routine capital funding specifically for HVAC system upgrades or replacements in 2020-21 and 2021-22. The projects supported through this funding include full boiler and air-handling system replacements, larger ductwork, updating occupancy sensors and direct digital control units for building automation controlling air-flow rates and portable HEPA filtration units in classrooms. Plus, in the 2020-21 school year, school districts used \$10 million in federal pandemic-specific funding to upgrade more than 45,000 ventilation filters in B.C. schools.

The updated provincial K-12 communicable disease guidelines were developed in collaboration with the BCCDC, Office of the Provincial Health Officer and K-12 education steering committee, which includes rightsholders and education partners.

The public health guidance for child care settings remain in effect.

The best way to prevent the spread of COVID-19 is for all British Columbians who are eligible to get vaccinated. Health authorities will target students, teachers and school staff in vaccination campaigns over the coming weeks.

"As part of your back-to-school preparations, we encourage youth to walk in now to get vaccinated at one of B.C.'s vaccination clinics, or go to a pop-up or mobile or community vaccine event around the province," said Dr. Penny Ballem, executive lead of B.C.'s immunization effort. "As students, parents and families prepare and plan for back to school, they can take advantage of the many locations and opportunities to receive a first or second dose. It's more convenient than ever to get a COVID-19 vaccine."

The return to school is being supported with additional resources.

In June, the Ministry of Education announced \$43.6 million in COVID-19 relief funding for the 2021-22 school year. This included \$25.6 million in new one-time funding to support health and safety measures, First Nations and Métis students, mental health services and independent schools. The remaining \$18 million was allocated for school districts to address learning loss due to the pandemic.

#### **Quick Facts:**

- There are approximately 1,900 K-12 schools in B.C. In the 2020-21 school year, 40 schools closed temporarily for a short period of time due to COVID-19.
- Two studies conducted by health authorities during the 2020-21 school year found:
  - in Vancouver Coastal Health, 92% of school-associated cases of COVID-19 were acquired from outside of the school environment; and
  - in Fraser Health, 87% of school-associated cases were acquired through community/household transmission, not from the school setting.
- The COVID-19 Immunity Task Force released a report in June that found there was no greater risk to school staff acquiring COVID-19 in a school setting compared to their community.

#### Updated COVID-19 guidelines for K-12 schools

The updated provincial COVID-19 communicable disease guidelines for K-12 schools in the 2021 -22 school year include, but are not limited to, the following changes:

- The mask mandate in place at the end of the 2020-21 school year will stay in place to start this school year. All K-12 staff visitors, and students in grades 4 to 12 will be required to wear non-medical masks in all indoor areas of the school and on school buses. Students in kindergarten to Grade 3 will be strongly encouraged to wear masks.
- The mask guidance will also be supported by a provincial health order on mask wearing.
- Cohorts, also known as learning groups, are no longer recommended by public health as a COVID-19 mitigation measure and will not be used.
- Local public health orders may be put in place for entire regions or communities, including schools. For schools, the local medical health officer may issue a recommendation for an individual school, a grouping of schools, a school district, all schools within the health authority region or some combination thereof, to implement specific additional health and safety measures during times of elevated risk.
- Any additional regional measures put in place by local medical health officers are likely to be similar to those in place during the 2020-21 school year, and may include:
  - limits on gatherings and events;
  - changing room arrangements or incorporating more activities that maximize space between people and reduce face-to-face contact; and
  - limiting visitors.
- The following cleaning frequency guidelines must be adhered to when cleaning and disinfecting schools:
  - General cleaning of the premises, and cleaning and disinfecting of frequently touched surfaces, at least once in a 24-hour period and when visibly dirty.
- Extracurricular activities are allowed in line with any local, regional, provincial or federal health orders in the community.
- Although physical distancing of two metres is no longer a recommended public health measure for the K-12 setting, there are strategies that schools can continue to use to create space between people and to support students and staff going back to school. Examples include:
  - reminding students and staff about respecting others personal space, and using visual supports, signage, prompts, video modelling, etc., as necessary;
  - using available space to spread people out where possible for gatherings and events;
  - taking students outside more often, where and when possible; and
  - managing flow of people in common areas, including hallways and around lockers,
     to minimize crowding and allow for ease of people passing through.

- Food programs (e.g., meal programs, cafeterias and fundraisers) can proceed under normal and regular operation.
- Water fountain use will no longer be restricted.
- Outdoor classes will still be encouraged, based on their health and learning benefits.

Public health continues to support the BC Centre for Disease Control's current health and safety guidelines for child care settings.

- The child care guidance recommends staff should wear non-medical masks when interacting with adults in indoor areas where physical distancing cannot be maintained.
- Children may wear a mask based on personal or family choice. However, infants under two years old should not wear masks, as it may make it difficult for them to breathe.
