13. INFORMATION ITEMS

a. Education Programs Update

Assistant Superintendent Wilson reported on the following district initiatives and events:

- The purchase of 10 Google Expedition Kits for use by schools. Training begins next week for teachers on how to use the technology and the types of curriculum connections the use of the kits can have for deep learning opportunities for students.
- "What's Working for Portfolios?" An in-district learning opportunity for teachers will be held on Thursday, March 1, 2018.
- Acknowledged the members of the MATA and CUPE Pro-D Committee for their work in organizing the workshops which included presentations by members of district staff. She also appreciated the invitation to attend the keynote sessions at Kwalikum Secondary School that same day.
- Acknowledged the work of the CUPE and MATA Dispatch Clerks for their work in replacing staff absences. Senior Staff are working hard to continually advertise and hire spare education assistants and teachers teaching on call to replace individuals who have received offers of full-time employment.
- The Curriculum Assessment and Evaluation Committee met last week to compile feedback on the first snapshot of student learning. A District student was invited to be a guest speaker and provided the members with

- thoughtful feedback as well as suggestions for what staff should be considering to help him, and other students, with their learning.
- Staff are organizing a Super Conference for Grade 7s on May 15, 2018 to celebrate being a teenager as they work through transitions. The conference will include presentations from Safer Schools Social Media, Gary Anaka: Brain Health & Wellness Educator and E.N.I.T.Y, and offer sessions on digital literacy and safety, information about resources from local organizations and a Panel of Grade 8 and 9 students to engage attendees to talk about their experiences attending SD69 high schools.
- Acknowledgement to the staff and students at Ballenas Secondary for their theatrical production of *Legally Blonde*.
- The Local Action Team has sponsored training in Neurosequential Model in Education (NME) which Ms. Wilson has attended.
- Played a video for the Board which was created by the Alberta Family Wellness Initiative, about how brains are built and, when they are not built in a certain way, the negative effects it can have on student learning. The video is titled Brain Builders and can be found on the AFWI site at http://www.albertafamilywellness.org/resources/video/how-brains-are-built-core-story-of-brain-development

b. Education Planning Update

Superintendent Koop updated the board on the following:

- Members of the BC School Superintendents Association (BCSSA) have been called to meet with the Deputy Minister of Education on Friday, March 2, 2018 to receive an update on the graduation program and the 10-12 curriculum and assessment.
- A meeting of the Island Chapter of the BCSSA was held on February 16, 2018. Ministry staff were in attendance and topics of discussion were the discuss accountability framework, enhancement to MyEdBC to allow staff at the school district level to access evidence of student learning to help inform the work they do, the future of the Classroom Enhancement Fund and a review the province is undertaking about the funding model.
- Regional forums are scheduled to discuss possible changes to the funding model and how money will be allocated to districts.
- Pat Duncan has taken over as the Superintendent, Learning Transformation, and has been directed by the Ministry to be 'front-facing' when working with Districts.
- The Annual General Meeting of the BC Public School Employers Association held on January 25-26, 2018 included an interactive session on Bargaining Preparation 2019 where the following five key approaches were discussed that will inform bargaining:
 - Innovative learning structures
 - Continuity of service to learners
 - Teacher workload
 - Teacher professional learning
 - Teacher recruitment
- Participation by the Superintendent and Assistant Superintendent in a
 planning group for a K-20 collaboration effort. The group includes mid to
 north island superintendents and members from Vancouver Island
 University and North Island College to cement districts' efforts around a
 shared understanding about the K-12 curriculum and the impacts of that
 learning on post-secondary education. The group will also be discussing
 governance structures for a mid-island partnership group of

Superintendents and Senior Faculty staff and operations oversight committee.

- Spring reviews with school administrators have been completed and the
 outcome of those discussions directs the work the Assistant
 Superintendent and the Secretary Treasurer do in regard to the staffing
 budget for 2018/19. The conversations also include a discussion of
 progress against the enhancing student learning plan goals. The level to
 which school administrators and learning services staff know their students
 places the District in a good position in terms of allocating funding in a way
 that makes the greatest difference for learners.
- The Superintendent led a Consensogram activity at the February DPAC meeting on the progress towards the Strategic Plan. The exercise provided a quick sense of where parents feel the District is at in moving forward on the four key priorities.
- The Superintendent is working with ThoughtExchange to create a staff/student reflection on the four key priorities and obtain feedback on some new ideas. He also plans to meet with the Board on March 16th to reflect on the mission, vision and values portion of the strategic plan with a focus on an aspect of renewal and rethinking.

c. 2018/19 Preliminary Operating Budget Process Update

Secretary Treasurer Amos provided a summary of feedback provided to date by stakeholders on the 2018/19 preliminary operating budget. That information will be reviewed to identify common themes and evolve into a budget 'wish list'. The Ministry is scheduled to make its funding announcement on March 14th which would then lead into the next round of discussions with stakeholders and marrying of the funding to a rationalization of a balanced 2018/19 budget.

VICTORIA – Today, students and government leaders called for a united front against bullying, especially cyberbullying.

Premier John Horgan, Minister of Education Rob Fleming and B.C. MLAs joined about 100 students on the steps of the B.C. parliament buildings.

"Everyone deserves to be treated with respect and kindness, whether it is in the schoolyard or on social media," Premier Horgan said. "I'm proud of the students who have come here today to make it clear that bullying, in any form and in any space, is unacceptable."

B.C.'s 11th-annual Pink Shirt Day event included spoken-word poetry and choir performances by Reynolds Secondary students with strong messages against cyberbullying. Students from Cedar Hill Middle school also came to show their support.

"Cyberbullying touches the lives of B.C. kids every day," Fleming said. "We all have a role to play in making sure students feel safe in the classroom, at home and online. By supporting positive online practices, we can help keep students safe and encourage respectful behaviour towards others."

Government has proclaimed today as Bullying Awareness Day, highlighting B.C.'s commitment to ensuring a safe and inclusive province for all. Those in attendance at today's Pink Shirt Day event in Victoria were encouraged to speak out against negative online posts, and to spread kindness instead, using the hashtags #PinkShirtDay and #ERASEBullying.

To ensure parents have the tools they need to support their children as they navigate the digital world, government is providing \$100,000 to the B.C. School Superintendents' Association (BCSSA) to offer social media education sessions to parents in every school district this school year. BCSSA will be partnering with Safer Schools Together to offer the session, called Raising Digitally Responsible Learners. This session was successfully piloted to approximately 120 parents last year.

"Parents play an important role in the safety and upbringing of their children both with respect to on and offline behaviours," said Carol Todd, mother and founder of the Amanda Todd Legacy Society. "Parents have a need to become better informed on how their children are using technology and, more importantly, how to support them in conversations related to social media and cyberbullying."

Parents and students can access bullying prevention resources, and an online anonymous bullying reporting tool at www.erasebullying.ca, part of the Province's comprehensive bullying prevention strategy, ERASE (Expect Respect and a Safe Education). Since its launch in 2012,

ERASE has received national and international recognition for its work in keeping students safer.

The Ministry of Education is also providing \$35,000 to the B.C. Confederation of Parent Advisory Councils to work in collaboration with the ARC Foundation (Awareness. Respect. Capacity) to develop a new set of SOGI (Sexual Orientation and Gender Identity) resources for parents, including a brochure and online videos. The brochure can be viewed at www.sogieducation.org and the videos will be posted there by the end of March.

"All forms of bullying and harassment have no place in B.C. schools. We need to keep our children safe from cyberbullying and intolerance in schools, in the community and at home," said Jen Mezei, president of the B.C. Confederation of Parent Advisory Councils (BCCPAC). "The social media presentations and SOGI resources will help parents have frank, open and informed conversations with their children, and teach them how to accept others, so we are all treated with mutual dignity and respect."



Elections Resource: A Guide for School Trustee Candidates



The Local Elections Engagement Committee has been working on *A Guide for School Trustee Candidates*, a resource material for prospective school trustee candidates who are planning on running in the October 2018 general local elections.

The *Guide* contains simplified information on the roles of boards of education, what school trustees do, what kind of skills are good to have when pursuing trusteeship, what the trustee schedule can be like, who is eligible to run, potential conflicts of interests, how to get started with campaigning, campaign financing and where to go for more information.

The *Guide* is not meant to cover all the details of trusteeship, but rather, give prospective candidates a glimpse of what the role is like, the impact they can make in leading and overseeing their community's valuable investments in public education, and how much learning and hard work it takes to be successful at trusteeship.

A Guide for School Trustee Candidates is now available on the BCSTA website and a version that can be customizable is also available so that each board of education can input their own schedule in the version of the Guide that they will distribute in their communities.

Finding a better way to support school districts, student success

VICTORIA – The review panel for the K-12 Public Education Funding Review has been selected by Minister of Education Rob Fleming, and the guiding principles for a new funding model have been finalized.

The principles were co-developed by the Province and the B.C. School Trustees Association, the co-governors of B.C.'s public school system.

Fleming has appointed Chris Trumpy, a former deputy minister of finance, as the chair of the panel, which will consult with stakeholders and undertake further research and analysis on a new funding model. He will be joined by the following panel members:

The panel will review the current funding model — how government distributes more than \$5.65 billion in operating funding to 60 boards of education throughout the province. The current system was established in 2002, and needs to be updated to reflect changes underway within B.C.'s education system, rising enrolment and to better support student success.

The goal of the review is to find a better way to provide equitable and predictable funding to boards of education. A new funding model should also look to better support vulnerable students, including children in care, children with special needs and Indigenous students, as well as rural and remote school districts, and those with fast-growing student populations.

Consultations with key education stakeholders will take place during the spring of 2018. The new model will be guided by the following principles:

- 1. Responsive: Allocate available resources among boards of education in consideration of unique local and provincial operational requirements.
- 2. Equitable: Facilitate access to comparable levels of educational services and opportunities for individual students throughout the province.
- 3. Stable and Predictable: Support strategic, multi-year planning for educational programming and school district operations.
- 4. Flexible: Respect the autonomy of, and not unnecessarily restrict, individual boards of education in the spending of their funding allocations to further student success.
- 5. Transparent: Calculate funding using a clear and transparent methodology.
- 6. Accountable: Allocate resources to boards of education in the most efficient manner and ensure that resources provided are being utilized as intended.

After consulting with stakeholders, the panel will summarize what it heard and recommend options for a new funding model to the ministry.

A new model will be developed by government with implementation planned for the 2019-20 school year.

Board Financial Governance and Accountability Requirements Update

As a follow up to the letter from the BC School Trustees Association (BCSTA) dated February 8, 2018 (see attached), this update will provide the Board with our progress to date.

The Ministry of Educations has set an expectation that many of the key financial governance areas need to be implemented by all Boards of Education no later than June 30, 2018.

Policies required to be in place:

Budget, monitoring and reporting - completed

Policy 4005 was adopted in April 2016

Accumulated Operating Reserve (Surplus) Policy - in progress

Draft policy is currently circulating through the Board Policy Committee

Audit committee - completed

On September 15, 2017 the Board of Education formally established an Audit Committee with oversight of audit and year-end financial statements

Initiatives to consider and begin implementation:

Training on the government's Taxpayer Accountability Principles – ongoing

Opportunities are presented through Board/staff discussions (budget deliberations, financial statement and reporting discussions) and through future BCSTA workshops

Financial Statement Discussion and Analysis - established and ongoing

The FSDA was prepared and introduced along with the presentation of the 2016/17 financial statements

Strategic planning - ongoing

Continues as part of discussions with Board and Senior staff through work on the District's long term Strategic Plan

Risk assessments - ongoing

 Included as part of the annual discussions around budgets/projections/capital planning/staffing needs. We are currently awaiting further information from the Ministry on their expectations in this area.

Other initiatives include:

Long Range Facility Plan - completed

 The LRFP was approved October 24, 2017, with the understanding it would be reviewed annually

Capital Planning Committee - completed

The Board approved the terms of reference for the committee on January 23. 2018.
 Its oversight of all matters arising from the planning for the physical facilities of the school district, will include the LRFP, annual facility grant and the Capital Planning process. The first meeting is scheduled for April 3.

BCSTA Support for new Board Financial Governance and Accountability Requirements

In the Spring of 2017, the Ministry of Education released the "Financial Governance and Accountability for School Districts of British Columbia" Guide in response to recent Auditor General reviews and special advisor reports that recommended strengthening the financial accountability framework for school districts.

The Guide was developed in consultation with the BC School Trustees Association (BCSTA), BC Association of School Business Officials (BCASBO), BC School Superintendents Association (BCSSA), Auditor General of BC and the Ministry of Finance, with the Ministry of Education as the final author of the document. The Guide is intended to support Boards of Education and school district senior staff in their work as governors and financial stewards of our education sector.

The Ministry of Education has set an expectation that many of the key financial governance areas in the document (e.g. the establishment of audit committees and district reserves policy) need to be implemented by all Boards of Education no later than June 30, 2018.

Ministry of Education Pending Requirements

By June 30, 2018, Boards of Education are required to have the following policies in place for the 2018/19 school year:

- Budget, monitoring and reporting policy
- Accumulated operating reserve (surplus) policy
- Audit committees

In addition to these requirements, Boards of Education are also expected to consider and begin implementation of the following initiatives by June 30, 2018:

- Training for all trustees and senior staff on the government's Taxpayer Accountability Principles, and incorporation these principles into school district codes of conduct
- · Financial statement discussion and analysis
- Strategic planning
- Risk assessments

BCSTA Support for This Process

To support successful implementation and continuous improvement in the sector, BCSTA is developing additional guides, tools and policy templates that will be made available to school districts over the next couple of months. The resource materials are currently being written and 'field tested', toward ensuring they adequately meet the needs of boards. All of the template materials are, however, intended to serve as a base or starting point for local boards, and may be modified to best address local circumstance and preferences. In addition, BCSTA will be coordinating trustee orientation and training sessions beginning this spring and into the next school year as part of our professional learning programs.



Guidelines, Tools and Templates

It is recognized that boards and school districts are at various stages of implementing these requirements. To best support districts, BCSTA is developing a comprehensive set of best practice materials, tools and policy templates that can be utilized by districts to either create and implement new policies or to assess their existing policies against best practices and recent government direction.

The guidelines will be made available on the BCSTA HUB starting in mid-February, and will be continually updated as new materials are developed, or as policy direction from the Ministry of Education and suggested best practices evolve.

Training

Orientation and training sessions for individual boards (and their senior staff) will be offered beginning this spring and extending into the 2018/2019 school year. The sessions are intended to orient trustees to these new requirements and to support boards in understanding their new roles and responsibilities when serving on audit committees or providing other financial oversight duties. The sessions will also provide training on school district financial literacy, which is a required competency of Audit Committee members. Boards that are interested in receiving this training and these services can contact BCSTA's CEO, Mike Roberts, directly.

In all cases, we recommend any training, as well as the final determination of district policy and procedures, be done in partnership with your senior staff.

Professional learning sessions are also being organized for the fall 2018 Trustee Academy and the New Trustee Joint Academy (with BCPSEA) in January 2019. More information on these learning sessions will be communicated early in the fall.

BOARD BYLAW 2

BOARD STRUCTURE

(Page 1 of 3)

PURPOSE

A bylaw to provide for the various procedures and conduct of meetings.

I. INAUGURAL MEETINGS

- 1. The Inaugural Meeting of the Board of Education, in each year following Trustee Elections, shall be held on the first Tuesday Monday after the first Monday after December November 1.
- 2. The Chairperson of the Inaugural Meeting shall be the Secretary Treasurer until such time as the Chairperson of the Board has been elected.
- 3. Election of the Chairperson shall be in accordance with the procedures outlined in Section II.
- 4. The interim Chairperson shall announce the results of the trustee elections prior to the swearing-in ceremonies.
- 5. The Swearing of Oaths and the taking of Declarations shall be done by the Secretary Treasurer, or by a Judge of a Court of Record or by a Justice.
- 6. The interim Chairperson shall call for nominations for Chairperson of the Board by ballot and then declare nominations closed. A ballot vote shall be held and that person receiving more than one-half of the total number of votes cast shall be declared elected. If no person receives a clear majority, the person with the least number of votes shall be dropped and a further ballot conducted. If a tie vote shall continue to occur, the meeting shall be adjourned for a period of not more than one week to a time when all members of the Board are able to be present.
- 7. Following the election of the Chairperson of the Board the order of business shall be:
 - a. Election of a Vice Chairperson of the Board
 - b. Motion to destroy the nomination and election ballots
 - c. Passage of Banking Resolutions
 - d. Discussion of Committee and Representative Appointments
- 8. The election of Vice Chairperson shall follow the same procedure as that for the Chairperson.

II. ANNUAL ELECTION OF CHAIRPERSON & VICE CHAIRPERSON OF THE BOARD (non-election years)

1. The Chairperson and the Vice Chairperson shall be elected for a term of one year commencing September 1st of each year, except in election years.

The election shall be held at the Regular Board Meeting held in August of each year, except in election years. In an election year, the Chairperson and Vice Chairperson terms will extend up to the trustee elections.



BOARD BYLAW 2

BOARD STRUCTURE

(Page 2 of 3)

- 2. Until the Board Chairperson is elected, the Interim Chairperson of the meeting shall be the Secretary Treasurer.
- 3. The interim Chairperson shall call for nominations by ballot for Chairperson of the Board and then declare nominations closed. A ballot vote shall be held and that person receiving more than one-half of the total number of votes cast shall be declared elected. If no person receives a clear majority, that person with the least number of votes shall be dropped and a further ballot conducted. If a tie vote shall continue to occur, the meeting shall be adjourned for a period of not more than one week to a time when all members of the Board are able to be present.
- 4. Following the election of Chairperson of the Board, the order of business shall be:
 - a. Election of Vice Chairperson of the Board;
 - b. Passage of Banking Resolutions.
 - c. Discussion of Committee and Representative Appointments.
- 5. The election of the Vice Chairperson of the Board shall follow the same procedure as that for the Chairperson of the Board.

Reference: Section 67 of the School Act

III. APPOINTMENT OF TRUSTEE REPRESENTATIVES

The Chairperson of the Board of Education shall annually appoint Trustee Representatives to External and District Internal Committees.

Trustee representation and participation on committees shall be approved by the Board of Education.

IV. TRUSTEE REMUNERATION

- 1. Trustee Remuneration will be established as follows:
 - In the first year of the term the remuneration will be the previous year's Provincial Average Trustee Remuneration as established by BCSTA
 - In all subsequent years of a term, the remuneration will be increased by the Consumer Price Index of the previous calendar year.
- 2. Each Trustee shall receive an annual remuneration of which two-thirds is paid as remuneration and one-third is paid as an expense allowance. The remuneration and expense allowance shall be paid on a monthly basis.
- 3. The Chairperson shall receive an additional 20% of the base Trustee Remuneration. The Vice-Chairperson will receive an additional 10% of the base Trustee Remuneration.
- 4. Each Board, during budget deliberations in the fourth year of its term, shall review the Trustees' Remuneration and make any adjustments the Board deems appropriate.

V. CHAIRPERSON AND PRESIDING OFFICERS

- 1. The Chairperson shall preside at all meetings of the Board, shall perform all duties imposed by the statutes and shall perform such other duties as may be prescribed by law or by action of the Ministry of Education.
- 2. The Vice Chairperson shall have the powers and duties of the Chairperson, in the Chairperson's absence or during the Chairperson's disability, and such other powers and duties as the Board may from time to time determine.
- 3. In the event that neither the Chairperson nor the Vice Chairperson is able or willing to take the Chair the presiding officer shall be such person as the Board may elect for that meeting.
- 4. The presiding officer shall rule on all points of order and shall state reasons and the authority for ruling when making a ruling.

A Board member shall have the right to appeal the presiding officer's ruling.

An appeal may only be requested immediately after a ruling and before resumption of business.
