6. BUSINESS ARISING FROM THE MINUTES

a. Oceanside Community Track Renewal Update

Superintendent Elder reviewed the information presented to the Oceanside Services Committee of the Regional District of Nanaimo on February 13, 2020 regarding the renewal of the track at Ballenas Secondary School and referred to the briefing note contained in the agenda package providing a summary of the results of that presentation.

Trustee Young then provided an update on the Oceanside Community Track Renewal Steering Committee meeting held on Monday, February 24, 2020. She noted that the main recommendations from that meeting were submitted by the fundraising sub-committee. A fundraiser, sponsored by the Chamber of Commerce, the Lions Club with support from the RCMP (who will have members in attendance in Red Serge) will be held on Friday, April 24^{th.} She encouraged everyone to promote and attend the event. The fundraising committee is also seeking volunteers to assist with planning and on the day of the event.

b. Climate Action Task Force Update

Trustee Kurland expressed his appreciation of having the opportunity to collaborate with Trustee Austin on the Climate Action Task Force.

Trustee Austin referred to her committee report provided in the agenda package and noted that the Climate Action Symposium proposed for the spring has been deferred to the fall as there have been conferences held in the mid island region over the past few weeks and another is planned by VIU in the spring. A subcommittee will be struck to help plan the fall event.

Trustee Austin thanked the Superintendent for reporting on the conversation he had with the Student Leadership Group where students thoughtfully answered the following question:

How do we balance the opportunities we have to create global awareness and global citizenship with the need to protect our environment?

Trustee Kurland noted that this generation of students would be the first in history to have to consider their lifestyle choices versus the impact of those decisions on the climate. They are setting the stage and tone for the future.

She also thanked the Director of Instruction and the General Manager of Operations for their work on and supporting the task force with data on the district's carbon footprint and how to incorporate climate action in the core competencies for students.

Trustee Young advised that she will be attending the (Gillian Wilson)on behalf of the Board on Saturday, February 29, 2020 in Vancouver. The event is being sponsored by the BCTF and the Surrey Teachers' Association. She will provide information from that conference to the Climate Action Task Force and the Board.

7. MOUNT ARROWSMITH TEACHERS' ASSOCIATION (MATA)

Judy Stewart, Acting President, commented on the following:

- She has attended a number of committee meetings since her return to work as Acting President and has observed a lot of the work being done by teachers to deliver as thorough of an education to students as possible.
- Recognition of the work of members on their own committees that supports student learning and appreciation for the work the school district does to provide feedback and incorporate members' ideas into the decisions made.
- Members are working through last year, this year and looking ahead to next year.
 There is trepidation and uncertainty as numbers are complicated to comprehend while continuing the knowing and learning in the classroom.
- Appreciation for allowing students to present their views as to what they want and how they would like schools to run.
- The budget released by the provincial government was hopeful in terms of providing some more funding for students and she recognized that it was due to some of the prodding by trustees around the province. She hoped that boards continue their efforts in order to have fully funded education in the future so that districts can incorporate all of the 21st Century learning.
- Teachers will be wearing red on Friday for BC Education.

12. INFORMATION ITEMS

a. Education Update

Gillian Wilson, Associate Superintendent, commented on the following district initiatives and events:

- Acknowledgement of the MATA and CUPE professional development committees on the sessions offered on Monday, February 24th.
- She and Tandy Gunn, District Principal of Learning Services, are undertaking School Reviews. The process helps to identify what supports are required at each school site and to drive staffing.
- Pink Shirt Day is on February 26th Lift Each Other Up is the Theme this year.
- Sheila Morrison, Principal at Errington Elementary, has taken over hosting the Free Throw competition which takes place this coming weekend. Kwalikum Secondary School is hosting the senior players.
- Biking is increasing in popularity in the community and the bike club currently has 70 individuals who will be cycling to the Tribune Bay Outdoor Education Centre. A large number of students and staff are also actively participating in the upcoming Hammerfest mountain biking event.
- A meeting was held on February 25th to review the recommendations provided in the Alternative Education Review Report and to plan next steps. That information will be presented at the April meeting of the Education Committee of the Whole. There will also be ongoing conversation across all schools in the district.
- A three-year calendar is being proposed for 2020-2023 and the draft has been circulated to staff and parents. A recommendation for approval will come to the Board at its March regular board meeting.

i. Update re: Stewardship and Climate Change Learning

Vivian Collyer, Director of Instruction, referred to her memo in the agenda package which shared how the redesigned curriculum and deeper learning processes are deeply connected to possibilities for stewardship and learning about climate change and climate action.

b. Superintendent's Update

Superintendent Elder commented on the following:

- Acknowledgement to the Board on the continued effectiveness of the committee structure.
- Acknowledgement of the work of the District Student Leadership Group which is meeting every couple of months. Approximately 20 students and staff meet and evidence of that work was heard at the most recent meeting which focussed around the ethical dilemma of global leadership vs carbon footprint. Students also answered the questions of what is working well, what requires attention and what are emerging priorities in the district.
- Acknowledgement of the work of the Associate Superintendent and the Principal of PASS/Woodwinds during the alternative education review process with support of a team from other districts. That work is supported through the dialogue which has occurred since the review with PASS/Woodwinds staff and other district staff to consider the future of alternative education as individualized, personalized and customized learning for students.
- The Superintendent has made a presentation to the Qualicum Beach Evening Rotary Club as well as the Chamber of Commerce to provide the community, through those organizations, with information as to what the district's purpose is and the service it provides to the children, families and larger community with a focus on the board's strategic priorities.

Acknowledgement of all district staff who are busy working in this school
year while planning for the next school year. What is often overlooked is
the significance of the pressure that comes with doing the best job
everyday for our learners and each other while planning for next year.

a. Island Health Open Board Meeting

Trustee Young referred to her report as provided in the agenda package, noting that the question period focussed on whether or not the Oceanside region provided enough primary care. The topic will require further in depth discussion.

17. TRUSTEE ITEMS

a. Referral of Category 4 and 5 Field Experience Requests to Education Committee of the Whole

Trustee Kurland referred to his rationale provided on the agenda and proposing that Category 4 and 5 Field Experiences (out of province and country) be presented to the Education Committee of the Whole for consideration prior to being recommended for approval to the Board.

Trustees discussed the proposal with consideration to the required timing of the Category 4 and 5 requests for approval in principal and then final approval since the requests and whether or not the board needed to vet the trips as they are vetted first by the school administrator(s) and then a member of the district leadership team.

Trustees also discussed clarifying the process in policy as it is currently being revised. Trustee Kurland stated that his proposal is drawing upon existing policy and was not related to climate action. What has changed is the creation of the education committee of the whole where participants can consider the curricular impact of the trip(s), obtain further clarifications and hearing from students as to how the experience will benefit them, etc.

c. Provincial Council Report

Chair Flynn noted that the Provincial Council met on February 21/22. The only emergent motion came from the Cowichan Valley School District regarding funding of career and dual credits courses, as, if the Minister funds those by headcounts it would have substantial financial ramifications for districts. The motion was unanimously passed as follows:

"that BCSTA request the Minister of Education ensure that if the new funding model moves to headcount funding vs. full-time equivalent funding, that career and dual credit courses be funded in addition to the headcount."

The Secretary Treasurer from Maple-Ridge/Pitt Meadows gave a presentation on the provincial budget released last week. It was highly recommended that trustees read the Ministry of Education 2019/20-2021-/22 Service Plan which contains references to what the budget will accomplish.

B.C. families to benefit from school-age child care on school grounds

VICTORIA – More options for before- and after-school care are on the way for parents with the introduction of new legislation that will make it easier for boards of education to deliver licensed child care for students.

"Having child care on school grounds is a win for everyone – children remain in familiar surroundings throughout their day, parents save time and money, and it keeps costs down by using facilities already enriched for learning and play," said Rob Fleming, Minister of Education. "Our government is committed to accelerating affordable, quality licensed child care spaces so families no longer have to face long wait-lists to access services that are often far from home and almost as expensive as their monthly rent."

This legislation puts into the School Act – for the first time – recognition that school boards can directly operate before and after school care. Currently, if boards want to offer child care they must offer it through a separate, licensed provider. Boards will be required to have a child care policy in place that addresses reconciliation and inclusive education commitments, while prioritizing available space on their properties not being used for K-12 students.

To ensure families continue to have services they can count on, the legislation will allow a minister's order to protect any spaces funded specifically for child care on school property.

"I've heard from too many parents and experienced first-hand as a family with a school-age child, that the lack of affordable before- and after-school care in our province has meant that they cannot return to work, even after their kids start kindergarten," said Katrina Chen, Minister of State for Child Care. "Studies show having child care at schools ensures smoother transitions for children and better educational outcomes, and it also helps parents with a single drop off and pick-up location."

These improvements build on work underway that will make it easier for school boards to work with licensed child care providers, share professional development and create inclusive, welcoming spaces for children to learn.

"Almost every parent has experienced the challenge of finding good quality before and after school care for their child," said Stephanie Higginson, president, BC School Trustees Association. "This amendment to the School Act enables boards of education to offer that care directly, creating a natural alignment with the educational programming already offered during the school day. We applaud the government for taking this important step in ensuring more child care options for school-age children."

Families throughout B.C. have benefited from the fastest creation of child care spaces in the

province's history, with more than 10,400 being funded in 15 months. Since launching in February 2018, the Childcare BC plan has also helped parents save more than \$320 million through the Affordable Child Care Benefit and Child Care Fee Reduction Initiative. Through these initiatives, nearly 29,000 families have received child care for no more than \$10 a day, since September 2018.

When a board of education wants to operate its own child care, it is eligible for operating and capital grants from the Ministry of Children and Family Development. Boards can use this funding to create non-profit child care programs based on the unique needs of their communities, with priority for culturally-relevant services for Indigenous families and support for students with special needs.

As part of the move towards making child care more accessible for families, personal education numbers (PENs) will also be expanded so children can be assigned a number before they formally start school – which is typically when they begin kindergarten at age 5. This change will reduce the paperwork that parents face and help provide seamless services from child care and early learning, to K-12 and post-secondary education throughout B.C.

To ensure children have access to high-quality learning opportunities and smooth transitions throughout their entire educational journey, the Ministry of Education also updated its Early Learning Framework in November 2019 after consulting with over 600 early child care and education stakeholders. The revised framework focuses – for the first time - on reconciliation and inclusive education, while expanding its scope to include infancy to eight years of age (formerly birth to five years of age).

"Before- and after-school care should be seen as part of a child's comprehensive educational experience, and this change supports child care providers in that aspect of their work," said Sonia Furstenau, MLA for Cowichan Valley. "When we begin to tap into the full potential of B.C.'s underutilized educational infrastructure, our schools will be transformed into centres with the remarkable ability to transform not just our youth but entire communities."

Investing in child care and early childhood education is a shared priority between government and the BC Green Party caucus and is part of the Confidence and Supply Agreement.

Quick Facts:

- The Education Statutes Amendment Act, 2020, will also include amendments to improve how public K-12 education is delivered and funded in B.C.
- Since 2017, the Province has approved over 2,600 new child care spaces on school grounds.
- As part of funding for new, replacement or upgraded schools, the Ministry of Education also provides extra dollars for school districts to create neighbourhood learning centres, with child care as a top priority.
- The Province has also made investments to improve supports to B.C.'s early care and learning professionals, investing more than \$19 million to provide over 11,500 early childhood educators with a \$1-per-hour wage enhancement. Another \$1-per-hour lift is to come in April 2020.
- To help with recruitment and retention, the B.C. government has also created 600 new early childhood education seats at post-secondary institutions, with 4,500 postsecondary students benefiting from bursaries to pursue a career as a child care professional.
- Funding for child care spaces and services, including before- and after-school care for school-age children, is separate from funding for K-12 education.

Students combat bullying at 13th-annual Pink Shirt Day

VICTORIA – Students throughout the province are gathering together to share stories of positivity and kindness, and to say no to bullying.

The theme of this year's Pink Shirt Day is "Lift each other up." Government has proclaimed Feb. 26, 2020, as Diversity and Acceptance Day, highlighting B.C.'s commitment to ensuring a safe and inclusive province.

Attendees at the Pink Shirt Day event in Victoria were encouraged to spread kindness to speak out against bullying, using these hashtags: #LiftEachOtherUp, #PinkShirtDay and #ERASEBullying

"I feel proud to stand together with B.C.'s courageous young people today, as we all work together to celebrate diversity and acceptance and say no to bullying," said Premier John Horgan. "Bullying in all forms is unacceptable, whether it's online or face to face. We need strong communities within our schools where no student feels alone. By working together to protect and support each other with kindness, tolerance and acceptance, we're building a safer B.C. for everyone."

Premier Horgan and Rob Fleming, Minister of Education, and MLAs were joined at the Parliament Buildings by Tru Wilson, transgender advocate; Carol Todd, parent and founder of the Amanda Todd Legacy Society; Travis Price, co-founder of Pink Shirt Day; and local students.

"We all have a role to play in making sure students feel safe in the classroom, at home and online. If we work together, we can help students feel safe and encourage respectful behaviour toward others," said Fleming. "The Erase program is continuing to provide our students with additional tools and resources to support their well-being and make a huge difference in our schools and communities."

The Erase strategy continues to grow as a comprehensive resource to better represent the issues facing youth and their communities today. Priority areas include a focus on social media and online safety, mental health and wellness, substance use, gang prevention and supporting students of all sexual orientations and gender identities.

Many new resources are available for students, parents, educators and community partners in B.C. schools this year as part of an over \$5.4-million investment in Erase, including:

- a \$2-million provincewide investment in school-based student mental health to help ensure kids can access support when they need it, and so they feel safe and connected at school;
- \$50,000 for social media and online safety education sessions for B.C. students and

- parents throughout the province. These sessions are an extension of the sessions offered over the last two years;
- a new video series, Raising Digitally Responsible Youth, was created in partnership with the BC Confederation of Parent Advisory Councils, to help parents and caregivers understand and teach kids how to safely navigate online and protect their digital reputation at the same time;
- a new Community Violence Threat Risk Assessment Protocol Guide to foster cross-sector partnerships to keep school communities safe and provide wraparound supports to students in need; and
- new trauma-informed practice resources for educators to develop compassion to help children, youth and adults, especially those who have experienced traumatic events and early hardships.

Overall:

Cross- border Social Justice Conferences have been happening for decades. They are sponsored by BCTF, and their locals or American Teachers' Unions. At this Conference, about 200 educators attended and the delegates came mostly from Seattle and the Lower Mainland. We had a choice of 2 out of many interesting workshops. All attended the Indigenous Welcome and the opening Plenary. I tried to pick the workshops that featured students and spoke to leading change. If you are interested, a more detailed report is available.

Indigenous Welcome:

Stamax (Trenton Pierre) provided a welcome and set the stage. In reconciliation we all are building a new positive, loving, and sustainable world.

Plenary:

As seen on the back of a denim jacket "Like the Ocean, we will Rise"

Panel of student activists moderated by Claudia Ruitenberg from UBC. I have included the questions and some of the most interesting answers from the students.

- 1. What do we teach while the world is burning?
- 2. How do adults work in political solidarity with youth climate activists? (students' comments)
- 3. What are you learning from school?
- 4. What would you like to learn more of?

Our rights as citizens (not about the 3 levels of government as that is too remote)

Do not have energy company sponsored events at the schools

About local political systems and organizing activism

Understanding intersectionality – how climate change impacts other cultures and nations Microskills of working together

Recognition that classrooms may need to change to facilitate this learning

Spend more time getting to know one another at the beginning of the year or semester Help with figuring out logistics and details (how to meet with politicians; meet with city councils, MLA's and MP's)

Allow and encourage collaboration among students and with teachers

Teach communication and group dynamics. Students need to know how to talk to someone How to create a strategy/what is needed/next steps etc.

Empower students to be decision-makers in their own lives.

- 5. Where are the guys? How come climate action is woman-led?
- 6. What can teachers do?
 - Take a risk and ACT!
 - Not enough to support or print posters...have to stand up
 - Testify and speak at School Board Meetings
 - Use opportunities available in the curriculum
 - Show empathy as many students spend a lot of time out of school on activism
 - Educate, listen and share

- Acknowledge that you are teaching in a new world of activism
- "We are not delusional to believe the world is delusional"
- This is NOT political (equally as political not to talk about it) Tell the facts and don't give your opinions.
- Don't assume that students know—teach and go deep
- Teach how to deal with "Youthwashing" where politicians take photo ops and then use them to their own benefit. For example, at a protest at a BC Liberal gathering, a photo was taken of the demonstrators and a liberal campaign sign was inserted behind them...
- Explain why LNG is in the Green BC plan
- Help students to know when they are being manipulated
- Teach about and recognize eco-anxiety teach how to break things down; what can be done; how to remain hopeful; to take action and to work to a positive and sustainable world
- There is both crisis and opportunity fear can be used to motivate action
- Do and say more than just "good job"
- Realize this is the biggest change ever and it will create a just world
- Tell students that dreams are possible
- Empower and listen to students
- Develop stuff with students and use experiential learning

7. Anything else

- Talk to unions especially teacher unions and labour councils
- Join with other groups like "workers for climate" in Victoria
- Students are planning toward a general strike in the lower mainland.
- Everything we do needs to be informed by Indigenous ways of knowing (Not many Indigenous people at this conference as they were involved in a blockade nearby.)
- Teach dealing with resistance and deniers (Ignore it, expect it and do it anyway) Do not engage as it is not worth it.
- Deal with "Incrementalism" and those who believe in climate change but do nothing about it.
- Talk about how social change worked in the past
