### 6. BUSINESS ARISING FROM THE MINUTES

### a. Vaccine Mandate

Chair Flynn referred to the recent missive from the Ministry for boards to determine whether or not they wished to mandate vaccine's in the district. She rose and reported from the In Camera Meeting held earlier in the day that the topic was discussed and the following recommendation was requested to be brought forward to the Regular Board Meeting.

### 21-105R

*Moved*: Trustee Flynn *Seconded*: Trustee Austin At this time, in recognition of high community vaccination rates and the continuation of in-school safety protocols, including masking and hand sanitizing, the Board of Education of School District 69 (Qualicum) will not mandate vaccines for its employees.

CARRIED UNANIMOUSLY

### b. Feasibility of WIFI Free Schools

Superintendent Jory reviewed the information contained in his memo provided in the agenda package regarding the feasibility of a WIFI free school (or schools), the health impacts of WIFI and the use of technology as a means for inclusion and its alignment with the BCEd Plan and curriculum.

His recommendation to the Board was to reject the concept of a WIFI free school and that it not be included in any further conversations at the Board table or during the upcoming facilities review.

Trustee Austin suggested that the topic could be included as a question during the upcoming facilities review to gauge whether or not it might be of interest to the broader education community.

### 7. MOUNT ARROWSMITH TEACHERS' ASSOCIATION (MATA)

Matt Woods, President, commented on the following:

- Support for the Board's decision not to mandate vaccines for employees as it was always the position of the BC Teachers' Federation that the government take responsibility for making that decision.
- Bargaining dates have been agreed to between the employer and the union beginning in December.
- 16 MATA members have been ratified to various district committees and MATA recognizes the extra time, dedication and commitment required by each of its members to support the district committees.
- The technology needs of teachers (is it reliable, does it work, how does one get it in the classroom and can it be accessed easily and readily?) He stated that teachers are moving away from teaching technology in isolation and are wanting it to be more integrated, intertwined and seamless when being used. Teachers would support a higher device/student ratio than what is currently in place.

# 8. CANADIAN UNION OF PUBLIC EMPLOYEES (CUPE) LOCAL 3570

Sherrie Brown, President, commented on the following:

- Support for the Board's decision not to mandate vaccines for its employees.
- Recognition and support to those who were caught up in the recent floods.

# 9. DISTRICT PARENT ADVISORY COUNCIL (DPAC)

Karri Kitazaki, DPAC Vice President, commented on the following:

- The New DPAC Executive is focusing on "back to the basics" with their PACs and parent/guardian volunteers and their purpose is to provide a voice for parents/guardians in the district (i.e. through the upcoming Facilities Review) and to look for opportunities to engage, empower and educate the community.
- Initial conversations indicated that exploratories and electives are important building blocks for the district's learners.
- While parents/guardians are excited about activities resuming in the district and the latest travel restrictions are disappointing, they appreciate the need to support local rationing.

### 12. INFORMATION ITEMS

### b. Superintendent's Report

Superintendent Jory reported on the following:

- Recognition of hardships friends and colleagues have been experiencing from the recent flooding
- Travel and fuel restrictions which are in place until midnight November 30<sup>th</sup>. The District is doing its part by limiting extracurricular travel and rescheduling meetings and learning sessions into the new year. Student bus schedules will not be affected.
- Reminder that the Ministry had made a decision not to send exposure notification letters. If there is a need for a student to remain home, the family will receive direct contact from Island Health. Information on COVID-19 in schools can be found on the island health website.
- Caution to the community to exercise restraint in social settings to reduce the transmission of the virus into the classroom.
- He mentioned the announcement that vaccines will be made available for students aged 5-11 years. At this time, there has been no instruction from Island Health asking the district to host vaccination sites. He noted that Island Health had sent home brochures and parent permission forms when vaccinations were available for students 12 and up. If the district is asked to host, that information would be shared with the public.
- Staff and students did a wonderful job acknowledging Remembrance Day with limited virtual events.
- Winter concerts will be going ahead with some being presented virtually while other will be in-person with limited seating and full safety protocols in place.
- A meeting with senior staff and secondary principals was held on the morning of November 23 to review grad cohort data.
- 2021 graduation results are now public and the district results are up slightly in some areas and slightly lower in others. The goal is to have a 90% graduation rate within the next 5 years.

# c. Educational Programs Update

Associate Superintendent Wilson, commented on the following district initiatives and events:

- There have been lots of opportunities to continue learning this year and part of the work is moving from 'knowing' to 'doing bridging the knowing/doing gap. One is through use of the *Universal Design for Learning* with examples of how that is implemented in schools and how to support teachers doing that work.
- In February 2022 Kindergarten teachers will be completing the Early Years Development Instrument (EDI) on each of their students. This is a questionnaire that includes questions on children's social and emotional development, health and well-being, language and cognitive development, and communication skills.
- The District will be resuming its Early Learning Framework (ELF) work for ages 0-8 years and a small grant has been received to ensure teachers are supported in looking at that framework.
- The first Curriculum Implementation Advisory Committee meeting was held on November 22<sup>nd</sup>. A few more MATA members are still to be ratified and the committee is scheduled to meet once per month to look at items that have budget costs which will support curriculum in the district.

- Acknowledgement of the work done by teachers during the month of conferencing at schools to communicate with parents either virtually or in person.
- On a visit to a Kindergarten classroom earlier in the day, the teacher shared the work the students have been doing around land acknowledgement and what they are thankful for. They are also learning the Hul'qumi'num language.
- An overwhelming number of applications were received for the Learning Grant. She and the Director of Instruction are reviewing them to see how they can support as many initiatives as possible this year.

Director of Instruction Terpstra, commented on the following district initiatives and events:

- Change to the drug, alcohol, and vaping cessation program where students will meet with the district Child & Youth Care Worker (CYCW) who guides them through a reflection package prior to their hearing with the District Drug & Alcohol Review Committee (DDARC) as well as providing followup support to the student as needed. The CYCW is also supporting work at the elementary schools and with most grade 8 to 9 cohorts.
- The Foundation Skills Assessments have been completed and were scored over the weekend.
- The Superintendent has organized a working session with Val Edgell to review the numeracy assessment with secondary school teachers and to review the FSA results with elementary teachers to discover what the data reveals and put those supports in place that are needed to support student learning.
- The District has reinstated its dinner learning series with the first being held on November 15<sup>th</sup> led by Lisa Bosio with a focus on Universal Design for Learning. Attendees included student support teachers, counsellors, nonenrolling teachers and administrators.
- The first French Advisory Committee meeting of the school year was held on November 22<sup>nd</sup> with a focus on creating a path towards a vision of the French Immersion Program by starting with the end in mind i.e. what does an immersion graduate student look like and what is the path from K-12 to guide them to that goal.
- Several teachers were involved in the Performance Standard Project. They designed lessons and will deliver them to students from K-12 and then choose some samples to send to the Ministry that show the reflection of learning at the proficiency standard, either developing or descending.
- The Education Technology Committee will be meeting early in the new year to review the Ed Tech Plan.

# 13. EDUCATION COMMITTEE OF THE WHOLE REPORT

Trustee Godfrey referred to the report as provided in the agenda package and provided highlights on the presentation by False Bay School – Digging with Dana and meeting the district's social worker, Marcela Ortiz, who works to support families, children and teachers in the community as well as being a conduit and liaison between other local ministries. She also noted that last year there were 15 approved Learning Grants and this year there are 22. There is consideration being given to having the projects showcased differently than at the Education Committee meeting i.e. in a Science Fair format.

Trustees and Senior Staff responded to comments/questions on the following topic:

- A number of parents and a past graduate of the program, expressed their dissatisfaction with the decision as well as the timing of the Superintendent's cancellation of the district's Vancouver Island Ski Patrol Program (VISPP).
- Superintendent Jory provided his perspective and rationale as to why he made the decision to cancel the VISPP. These included:
  - Low enrolment
  - Number of students attending from other districts
  - Students taking the program more than once
  - Students attending who are already grad eligible
  - Batch loading of courses
  - Amount of teachers' time and funding being allocated to the program compared to the low number of students in the program.
  - Not meeting ministry criteria for that type of program to generate funding and credits.
- Parents disagreed with a number of the reasons and asked that the Board consider allowing the program to continue this year with a view to reorganizing it for the next school year.
- Staff will be reaching out to the students who were enrolled in the program to see if they can be connected to other types of experiences for credits.

> Gaming grants help keep students in extracurricular activities Updated Dec. 6, 2021

VICTORIA – Kids in B.C. will benefit from participation in a wide range of school activities thanks to Community Gaming Grants funding that is going to more than 1,300 school advisory councils.

"We've been through so much over these past couple of years, and parents have been champions in our schools, working hard to keep kids connected with safe and rewarding extracurricular activities," said Josie Osborne, Minister of Municipal Affairs. "Activities like these provide tremendous benefits for children's health and well-being, and they help keep students active and engaged in learning."

In total, nearly \$11 million in Community Gaming Grants is supporting parent advisory councils (PACs) and district parent advisory councils (DPACs) in the 2021-22 school year. Schools in British Columbia receive funding each year through PACs and DPACs for activities that benefit students' social, cultural and physical health.

"Extracurricular activities are so important for students so they can connect with their friends and maintain their physical, social and mental health," said Jennifer Whiteside, Minister of Education. "Through Community Gaming Grants, PACs and DPACs across the province provide a wide range of extracurricular activities for students, allowing them to build new friendships, develop life skills and share more experiences together."

Schools offer many extracurricular experiences for K-12 students, including sports and playground activities, drama, writing and music programs, and graduation ceremonies with support from Community Gaming Grant funding. PAC groups use the funds to put on music, dance and theatre performances, purchase computers for extracurricular activities such as robotics, yearbook and photography clubs, and holding social gatherings such as movie nights.

"The ongoing pandemic has severely limited the ability of parent advisory councils to raise funds in support of numerous school programs," said Andrea Sinclair, president, BC Confederation of Parent Advisory Councils. "Parents are grateful that Community Gaming Grants will be distributed to PACs throughout the province, thereby ensuring that the students' experience at their school will continue to be enhanced while reducing the burden on families."

The Community Gaming Grants program has put British Columbian's health and safety first by requiring that all grant funding complies with the provincial health officer's orders, while continuing to provide flexibility for those organizations whose programs and services have been affected by the pandemic.

# Quick Facts:

- Every year, commercial gaming revenue funds essential government programs and services, including health care, education, justice and social services and the Community Gaming Grants program.

# Funding to school districts to keep kids out of gangs

VICTORIA – To help vulnerable young people avoid gang and criminal lifestyles, the Province is providing more than \$486,000 in grants to fund mentorship programs in 24 school districts around British Columbia.

Administered through the School District Mentorship Grant Program, this funding supports school districts to develop local programs and initiatives for youth who encounter gang recruitment. Students will receive coaching and mentoring with a focus on building stronger and positive connections to community, culture and relationships.

"We need to work together to make sure young people are knowledgeable and resilient," said Mike Farnworth, Minister of Public Safety and Solicitor General. "By supporting our schools and investing in early intervention and prevention programs, we're addressing the root of the issue and diverting vulnerable youth from joining gangs in the first place."

Programs will be delivered within respective school districts in partnership with educators, nonprofit organizations, Elders, counsellors and others. Many of the school districts will also deliver culturally supportive programs to young people, as well as programs to vulnerable Indigenous youth. Examples include:

- Delta School District: intervention and counselling with youth at risk and families;
- Nanaimo-Ladysmith School District: one-on-one mentorship and cultural support to assist youth at the highest risk of being recruited by a gang or who are currently gangafiliated; and
- Peace River North School District: youth care workers will provide mentorship and counselling to at-risk youth, as well as positive group activities.

"Our government is committed to working together with education and community partners, Elders and counsellors to provide youth with brighter futures and end the gang violence threatening our communities," said Jennifer Whiteside, Minister of Education. "These important new mentorship programs are another way government is working to ensure all B.C. students receive an education free from discrimination, bullying, harassment, intimidation and, most importantly, violence, for generations to come."

The School District Mentorship Grant Program was developed by the ministries of Education and Public Safety and Solicitor General as part of the Erase strategy, an education-based antigang program. The Erase program also carries out analysis of concerning or risky student behaviour, educator training, identification of local resources for support and school district capacity building.



<u>Mandate</u> – FAC provides advice, recommendations and feedback to senior staff on matters relating to French language programs in the District.

<u>Role</u> - FAC meets at least three times each year to discuss strategic priorities as they relate to funding allocation and program development:

- To promote and support French Language learning in SD69
- To support relevant, accessible, high quality FSL programs that optimize resources and appropriately complement district programming
- To help integrate FSL program guidelines within the district's learning framework, as well as serve as a forum for ongoing sharing of perspectives on program directions
- To ensure our district programs align with federal funding guidelines

# 1) School Updates

- a) École Oceanside Elementary:
  - It was mentioned that we have several itinerant teachers offering programs in French: Aleks Tremblay, Music; Devon McLeay, Library; Samantha Stagg, Art; Simin Rupa, PE; Amber Van Der Mark, ADST.
  - Angela Dodd has a new role at the school, assisting Brayden Gordon, VP and French Coordinator at EOES. This new role includes supporting Immersion teachers with researching and ordering resources, lesson planning, chairing monthly FI meetings and encouraging teacher professional development. The time allotted for this new role is two afternoons and one full day a month.

  - Department Meeting. Ballenas teachers want to strengthen immersion program
  - New Fr. Imm teacher Melissa Gravel. Fluent in French. fitting in great.

- Question regarding the DELF assessment was asked and answered that it is a Language Proficiency Test used all over the world and available in Nanaimo and UVIC (possibly).
- c) Odyssey: Language Assistant Ines Mentec
  - Ines is currently working with primary classes during her time at EOES. She is working with small groups to develop oral French speaking and comprehension skills. She is also working on reading skills. She will be working with a new group of learners and teachers starting in January. She will also be part of any cultural events at the school. See above for involvement at Ballenas one day per week.
- d) Professional Development:
  - October 5<sup>th</sup> The Immersion staff worked together on a French Language Arts Learning Progression from K to 7. The Primary teachers worked on sound families and the Intermediate teachers worked on a writing continuum.
