- 1. Acknowledgements by Ray. Reminder to all this meeting is being recorded
- 2. Introductions in person and virtually. In Attendance Ray W AES, Lisa H. -KSS Raani D EOES, Matt W MATA, Maleah B CEAP/PASS, Erin- EES, Jackie-NBES Laura W. - 3. Adoption of the agenda motion made by Lisa 2<sup>nd</sup> Jacquie H. Raani motions to move the elections to item 7, Matt 2<sup>nd</sup>. Both motions. Passed.
- 4. Approval of minutes. Approve minutes at the next meetings as they have not been posted online yet.
- **5. Delegations** (5 min) there is no delegations this meeting.
- 6. Information Request Items (60 min)
- **Bus registration fees** Do bus registration fees cover administrative costs to register riders? What is the total dollar amount collected in bus registration fees?
  - Rudy \$25 per person, to make sure ridership is committed. Busses were sometimes running ½ empty. Ridership registration went from 2000-1800. Fees were waived if you could not afford it. Approx 1300-1500 riders. New software for the bus system making changes. Fees covered software and administrative costs. Jacquie asked for a specific number and he estimated 1500x\$25 as many people opted to not pay.
- Backpack Program What is QSDs role in the Backpack Program? How much funding does QSD provide and where does the funding come from? Are there currently families on a waiting list for the backpack program?
- Rudy. School District 69 is a <u>partner</u>, it is not their program. SD69 supports the Backpack Program. However, the money used to support the Backpack Program is from the Feeding Futures allotment, targeted funding to feed students. So that not only feeds students at all our schools with food programs, and they are also, families are fed through the Backpack

Program, and SD69 makes a contribution to that. The wait list, people do end up on the wait list through, they apply, and then usually get to that family part of the program as soon as possible. So technically, like when I asked last week, there was no families on the wait list. \$40K from feeding futures went to it. Lisa stated that she knows of families who have contacted her about support through the Oceanside Family Program, a volunteer led initiative saying they were on the backpack program last year and are not able to be on it this year and are on a waitlist even though Gillian Wilson wrote saying there is no wait list. Rudy will look in to this and get back to Ray.

- EAs What happens when EAs request a day off and no coverage is found?
  - Rudy states the schools deal with absenteeism, including EA absenteeism, as best as
    possible. If an EA is absent the person is not replaced then administration do the best
    by placing people the best they can. Rudy says they have as many EA's as possible.
    This happens often in all sectors, at BSS every day. District prioritize teachers and
    EA's.

Does Qualicum School District have a policy for EAs on call not to have other employment?

This is actually a collective agreement item. Defer to CUPE. The district does not have this policy.

If an EA on call is unavailable 3 times what happens?

This is also part of the Collective agreement so Ray will follow up with CUPE.

• NRT - Parents have requested the answers to 15 specific NRT questions. Several of the questions can be answered with a yes or no.

What is NRT and why was it prioritized in the budget?

• Rudy: There is some misinformation out there. NRT is not just Cale Burke. He now has a role in our NRTs, but NRTs don't come from him.

**Needs response teams.** School district student support services programs. Last year district did a student services review and from that Developed a plan, out of that needs were to be addressed. As a district wanted to add some staffing, MATA had some alternate ideas and in the end NRT was made with time and space to collaborate with TOC support for teachers to collaborate, focused on needs that were identified in schools and by teachers. Rudy also wanted to add the context. As a school district, they hire or bring in outside support for many initiatives related to the strategic plan

.. The school district hires outside support related to strategic planning. All of these people are outside, tied to supporting strategic planning. Rudy shared Framework for learning slide. It is on website for parents to view.

What is the intended outcome of NRT and how will it be measured?

 Rudy: Opportunity for teachers to align their role teachers work in partnership with a facilitator. Within the work day for preplanned learning activities. It is to enhance student learning.

Whose needs are prioritized in NRT?

Rudy: Student's needs. Improve learners, the measurements are improvements in learning.

How is NRT expected to improve learning for the average student?

Rudy: Teachers can focus on what the needs of the students are. Collaboration by teachers is impacting learning in the classroom and is considered by most as the most effective way to improve learning for kids.

Is there an example of another Canadian school district that has paid for NRT and has data showing improvement after NRT training?

Rudy: SD69 made up the acronym. But really it is just collaboration in education.

Is NRT mandatory for teachers and will teachers provide feedback on NRT in an anonymous survey?

Rudy: Its encouraged and optional, there is feedback for improvement, no survey in place. Jacquie asked how many teachers have participated, as the budget line item was over \$200K. How many hours of services are provided for the budget this year? Half day of collaboration starting soon. 30-40 NRT's last year. There was no budget last year but district made it work. Last year district had additional students and used that TLC coverages to cover it. Jacquie asked how to actually measure the outcomes? Rudy: the focus on improving reading, Read teams for the past 5 years comes from the Board direction to improve literacy. Their goal is to graduate more students. MATA teachers can reach out to their union to give feedback on NRT's Jacquie asked for justification for this amount of spending, surprised that this level of spending would be approved for a project without any anticipated number of hours of collaboration?
Rudy: believes 50-100 collaborative groups. Typically 3-5 teacher per group

Was it considered to use the same amount budgeted for NRT, for teachers to upgrade via specialty certificates or workshops that they felt would best help them manage behaviors and challenges in the dern classroom?

Rudy: NRT came from strategic plan. Certifications and workshops are teacher responsibility. Teachers also can attend provincial pro d, lots of teachers go to those. Matt from MATA: infographic, teacher collab piece, Curriculum Implementation Advisory Committee. CIAC. CIAC will determine if a survey is needed or not. He feels there is a good feedback loop within the internal processes. Professional learning community, collaboration amongst teachers improves how they do things. MATT: students create the needs, and the teachers prioritize the needs. Teachers determine the need that is best serving them. Jacquie: If it is teacher driven, why was it decided above and beyond PRO D? The purpose of Pro D, teachers determine what they need. The admin can not tell a teacher what to do on those days, it was bargained in. Learning community like an NRT can be shaped by district administration providing a more restrictive environment. Jacquie asked for clarification. Matt MATA explained difference between PRO D vs Collab time.

• **COW meetings** access to the information from the **C**ommittee **O**f the **W**hole meetings. Would like clarification from the trustees as to why the motion to record meetings was rescinded?

Eve Flynn, Board Chair. COW education, finance and policy. Notes are there for board meetings. But in context of the policies, deliberation is done at the COW, opportunities for people. RECORDED budget meetings, education COW, seeing in recorded fashion after that fact doesn't provide opportunity. Regular board meetings on YouTube. She is concerned with Al using her voice. Did the decision to rescind the recordings benefit anyone. Policies take place over 3 meetings. There is no discussion to restoring the recording of the meetings. Jacquie: Please ask the board what they want to see from parents for next year? What information can we provide? what evidence do you need to see from us? A lot of parents don't understand the flow of the district, what does the board need to see to restore? Felicia: she often attends board meetings and finds them transparent. — is it on the table could be once every 3 months in the evening so that parents can attend? Julie Austin presented a motion back in May/June. Table is open every month, parents need to write in. Raani: asked for the board meeting minutes to be posted more timely way. They will work on that. They have given Ray the info on who is attending for each meeting. Liaison trustees can attend a PAC meeting at the school if the PAC's request them to attend.

MATA 9 teachers to 1 admin the provincial average is 12.5 to 1 admin. Dr Jory feels we are in the middle zone, teachers and leadership to explore moving forward Government funding down. Trustees asked for Data. They gave Bus updates/
