Dear Parent(s) and Guardian(s):

RE: The Foundation Skills Assessment (FSA)

The Foundation Skills Assessment is an annual province-wide assessment of B.C. students' academic skills in grades 4 and 7, and provides a snapshot of how well B.C. students are learning foundation skills in Reading Comprehension, Writing, and Numeracy.

The *Information for Parents* brochure provides a description of the FSA, as well as the purpose, time, preparation and costs of this province-wide annual assessment of grade 4 and grade 7 students. It also outlines the value the FSA has for parents and educators and addresses some of the concerns that have been raised about it.

You may receive information from the Mount Arrowsmith Teachers' Association (MATA), a local of the British Columbia Teachers' Federation (BCTF). This information may outline the BCTF/MATA concerns about the upcoming FSA. It reflects their point of view and not those of the Ministry of Education.

We would like you to know the following:

- The Ministry of Education expects that all students will write the assessment, except those with exceptional needs or extenuating circumstances such as illness or family emergency.
- The Principal of the school is given responsibility for determining any exclusions from writing the assessment based on criteria set by the Ministry of Education.
- Principals will notify parents of any students whose Individualized Education Plan (IEP) documents a rationale which would warrant exclusion from writing the FSA.
- If a parent believes their child should be excluded from writing the FSA on the basis of illness, family emergency, or other
 extenuating circumstance, that parent should contact the Principal in advance of the assessment dates to allow for proper
 adjudication of that request.

In School District 69, we use the assessment data in triangulation with classroom and school assessments. The information is reviewed to determine what we know about cohorts of students and individual students within our schools. From this process we can determine what, and if, additional supports are needed for individuals or groups of students.
