For this purpose, I accept the following conduct for success:

I will attend regularly and consistently. The only limits on my attendance will be work, childcare or health issues. While at school, I will engage in learning behaviours that consistently work towards course completion.

I understand that I must maintain the timelines that I am given for each subject and I will keep my course work on schedule. I will be in regular contact with my teachers. I understand that if I cannot attend due to illness or other issues, I will contact my teachers and the school as well.

I understand and I will abide by the **scheduled breaks for PASS which will posted in classrooms.** School hours will be reviewed every year to best fit the needs of the majority of students.

I understand that PASS is a place of learning. I may be asked to leave if my participation is unproductive.

I understand that disruption of other students, e.g. coming to school and pulling other students out of class, will absolutely not be tolerated.

I understand that substance use and school absolutely do not mix. Therefore, I commit to coming to school clean and sober.

I understand that the PASS/Woodwinds/CEC/Springboard Daycare Complex is a smoke free environment and should I chose to smoke the only place that I will smoke is off of all properties.

I understand that plagiarism/cheating is completely unacceptable. I understand that I am a unique individual with my own perspective, as such I commit to doing my own work free from plagiarism etc.

I understand that I am expected to dress appropriately while attending school, (see PASS/WW/CEC Dress Code).

I understand that I am required to sign and commit to The CEC/PASS/WW Computer Acceptable Use Policy. My computer privileges will be removed if I do not follow this agreement completely.

I will help create a learning environment where everyone feels welcome.

I understand that under the terms of **Section 85.3 of the British Columbia School Act**, a Board of Education may refuse to offer an educational program to a student 16 years of age or older if that student:

- A) has refused to comply with the PASS Code of Conduct, other rules and policies, or
- B) has failed to apply himself or herself to his or her studies.

Finally, the expectation of the PASS Program is that I AM A POSITIVE, RESPECTFUL AND RESPONSIBLE PERSON AND THAT I AM HERE BECAUSE I WANT TO MAKE THE BEST OF THE PASS SCHOOL OPPORTUNITY.

POLICY

- <u>Special Consideration</u> In application of our school's code of conduct, special consideration may apply to students with Special Needs if those students are unable to comply due to having a disability of an intellectual, physical, sensory emotional or behavioural nature.
